1. Introduction

The Government of India established the National Board of Examinations in Medical Sciences (NBEMS) in 1975 with the objective of improving the quality of the Medical Education by establishing high and uniform standards of postgraduate examinations in modern medicine on All India Basis and utilizing existing healthcare infrastructure for capacity building.

The prime objectives of NBEMS is to elevate the standards of post graduate medical education in modern medicine and conducting examinations of high standard on an all India basis.

NBEMS provides a common national standard for evaluation of minimum level of attainment of the knowledge and competencies of post graduate and post doctoral training.

NBEMS conducts post graduate and post-doctoral examinations in approved disciplines leading to the award of Diplomate of National Board (DNB), Doctorate of National Board (DrNB) and Fellow of National Board (FNB). NBEMS also conducts the following examinations on an All India basis on Computer Based Platform:

2. NBEMS Fellowship Programme

Well-equipped Centres have been identified and accredited by NBEMS in the concerned sub-specialties. Students with DNB/MD/MS/MCh/DM qualification in the concerned specialty are eligible for fellowship programme. Selection to the fellowship programme is based on an entrance test and admission to the courses will be through centralized merit-based counselling. The trainee will go through a structured training programme, maintain a performance record book and undergo an examination at the end of the training. Students will be awarded Fellow of National Board (FNB) qualification at the annual convocation of NBEMS.

NBEMS offers Post Graduate/Post-doctoral fellowship courses with following objectives:

- ◆ To facilitate and encourage post-graduates aspiring to learn skills and competencies in their area of interest.
- ◆ To provide highest quality of specialty services comparable to any country in the world.
- ◆ To recognize "Centre(s) of Excellence" and to identify experts in various sub-specialties and allied sciences.
- ◆ To create a forum for high level scientific interaction between expert groups.
- ◆ To facilitate and encourage our young post-graduates aspiring to provide for higher level of specialized services in own country.
- → To prevent brain drain of qualified medical professionals leaving our country for further academic achievements.

- ◆ To improve and promote the existing medical institutions in India to perform high professional services in various fields.
- ◆ To promote medical research and Innovations adaptable to the socioeconomic status and culture of our country.
- ◆ To conduct evaluation by appropriate mechanism for assessment of training programme examination before certification as specialist by the National Board of Examinations in Medical Sciences.

RECOGNITION OF FNB QUALIFICATIONS

The Nomenclature of the FNB qualification awarded by the National Board of Examinations in Medical Sciences is "Fellow of National Board". The FNB qualifications are recognized qualifications in terms of the Gazette notification dated 10th August 2016. (Annexure A)

3. Information for Students

- 3.1. FET 2024 is a qualifying-cum-ranking examination for admission to Fellow of National Board (FNB) courses of 2024 admission session.
- 3.2. Student may kindly note that appearance in FET 2024 does not confer any automatic rights to secure a NBEMS Fellowship seat. The selection and admission to Fellowship Programme in any National Board of Examinations in Medical Sciences Accredited institution running FNB courses is subject to fulfilling the admission criteria, eligibility, medical fitness and such criteria as may be detailed in the information bulletin. The eligibility shall be determined at the time of counseling/admission/registration to the programme. In an event, a student is later found not to fulfil the criteria prescribed, his/her candidature as well as the result for the FET shall deemed to be cancelled.
- 3.3. Students are advised to read the Information Bulletin carefully and go through the instructions regarding submission of online application form given in the information bulletin as well as on FET 2024 index page on NBEMS website https://natboard.edu.in before starting online submission process for FET 2024.
- 3.4. Students are deemed to have read, agreed and accepted the Information Bulletin and the terms and conditions in the information bulletin for FET 2024 on completing the online submission of application form.
- 3.5. A student can submit FET 2024 application form only once. If a student is found to have submitted more than one application form for FET 2024, NBEMS may issue admit card to the application bearing higher order Application number (application ID) and cancel other application(s) forfeiting the fee for them. In an event any unfair practice is detected by NBEMS at any stage of

examination/admission process, NBEMS may cancel the candidature of such Students and debar them from appearing in any examinations conducted by NBEMS as per provisions of the Unfair Means Guidelines.

- 3.6. Students should ensure that all the information entered during the online submission of application form is correct and factual. Information provided by the students in the online application form shall be treated as correct and NBEMS will not entertain, under any circumstances, any request for change in the information provided by the Students. The option of editing certain information entered in the application form shall be available to the students during the edit window. Please refer Chapter on Instructions to fill Application Form for details regarding Edit Window.
- 3.7. NBEMS itself does not edit /modify/alter any information entered by the Students at the time of online submission of application form under any circumstances. There is no provision of accessing the application form to make any changes in the information provided in the application form after closure of edit window. Such requests to make any changes shall not be entertained. Students, however, shall be able to rectify the deficiencies in their application (if so communicated by NBEMS) regarding images uploaded by the prescribed cut-off dates.
- 3.8. Please refer Chapter on *Instructions to Fill FET Application Form*. Students are advised to review their applications submitted and rectify the deficiencies, if found any, within the window as detailed below. Students may note that deficiency in the application form pertaining to images uploaded may be communicated to them by NBEMS, however, it shall be the sole responsibility of the applicant to ensure that the application submitted is complete in all aspects as per the information bulletin. If any deficiency in the application which was not communicated by NBEMS to the applicant before conduct of the examination, is noted at any later

stage, this would not create any equity in favour of the candidate and confer any rights on to the Students for grant of eligibility for the examination.

- 3.8.1.Edit Window: Students who have successfully submitted their payment for the application during Application Submission window shall only be allowed to edit their applications during 20th January 2025 to 22nd January 2025. No new application can be registered or payment can be made during edit window. Any information/document can be changed/corrected during the edit window except for Name, Test City, Nationality, Mobile Number and Email ID. Information can be edited any number of times before the closure of the window. The last submitted information will be saved in records.
- 3.8.2.Selective/Final Edit Window: Deficiency related to images uploaded (photograph, Signature, Thumb Impression) shall be intimated to the concerned students and same can be corrected during the selective edit window i.e. 31st January 2025 to 3rd February 2025. No further opportunity shall be given to make corrections. Students are advised to submit the images in their application as per prescribed image upload guidelines. Failure to submit images as per guidelines and/or failure to rectify the images shall invite rejection of the application.
- 3.9. Application for FET 2024 can only be submitted online through National Board of Examinations in Medical Sciences website https://natboard.edu.in There is no other methodology for application submission. Application submitted through any other mode shall be summarily rejected.
- 3.10.Students who fail to submit duly completed applications with requisite documents and/or fail to rectify the deficiencies in the application by the last date prescribed for rectification shall be declared ineligible. Admit Card shall not be issued to students

who are declared ineligible. In such cases, the entire fees will be forfeited.

- 3.11. Applications of students producing false or fabricated records will not be considered and such students will be further debarred from appearing in the future examinations of NBEMS. Action as deemed appropriate by NBEMS will be taken if false or fabricated records/information is submitted or any unfair means are used.
- 3.12. Students are advised to ensure that no mandatory column in the online application form is left blank. In the event of rejection of the application form, no correspondence/request for re-consideration will be entertained.
- 3.13.Students should ensure before applying for the examination that **they possess or likely to possess by 31st December 2024** the Degree/Provisional Pass Certificate of MD/MS/DM/MCh/DNB/DrNB qualification in the eligible specialty duly recognized as per provisions of NMC Act 2019 or an equivalent recognized qualification.
- 3.14.An International Student for Fellowship Programme (FPIS) should be duly registered with appropriate registering authority in his/her own country where from he/she has obtained his/her PG Medical qualification which is duly recognized by the corresponding Medical Council or concerned authority and applicable provisions of the NMC Act, 2019. If it is found at any stage that the PG Medical qualification of the student is not a recognized qualification, the candidature/result shall be cancelled/deemed to be cancelled.
- 3.15.Students should go through this bulletin carefully for eligibility criteria before applying. Queries pertaining to eligibility and other issues will only be entertained if the information requested is not given in the bulletin of information or on NBEMS website. No Queries of the Guardians/Parents/Spouse will be entertained on

telephone with regard to the eligibility and disclosure of the results.

- 3.16. Submission of incomplete online application form not in accordance with prescribed instructions shall invite rejection of applications. In such cases, the examination fee shall not be refunded.
- 3.17.Student found ineligible at any stage of FET 2024 Examination, will not be permitted to appear in the examination. In an unlikely event of any ineligible student appearing and/or passing the FET 2024 examination, the results/candidature of such student shall be cancelled and/or is deemed to be cancelled, even if result has been declared or Pass Certificate has been issued.
- 3.18.NBEMS reserves the right to withdraw permission, if any, granted inadvertently to any student who is not eligible to appear in the FET 2024 even though the admit card/roll number has been issued or name/roll number is displayed on NBEMS website.
- 3.19. Fee shall neither be carried forward to a future exams nor refunded under any circumstances.
- 3.20.Students' eligibility is purely provisional & is subjected to the fulfilment of eligibility criteria as prescribed in this Information Bulletin.
- 3.21.Instructions in the information bulletin are liable to change based on decisions taken by the NBEMS from time to time.
- 3.22.Instructions in the information-bulletin are liable to change based on decisions taken by the NBEMS /MoHFW/NMC from time to time. There is no equity or any rights that are /or deemed to be arising in favour of student. Students are required to refer to the latest bulletin or corrigendum that may be issued to incorporate

- these changes. Refer NBEMS website https://natboard.edu.in for latest updates or corrigendum.
- 3.23.NBEMS reserves its absolute right to alter, amend, modify or apply any or some of the instructions/ guidelines contained in this information bulletin.
- 3.24. The existing schedule, pattern, policy and guidelines are for ready reference only but in no way, they are or are ought to be treated as representative or acknowledgment of fact that NBEMS is bound to follow the same in future.
- 3.25.In case of any ambiguity in interpretation of any of the instructions/ terms/ rules/criteria regarding the determination of eligibility/conduct of examinations/ registration of students/ information contained herein, the interpretation of the National Board of Examinations in Medical Sciences shall be final and binding in nature.
- 3.26.Request shall not be entertained for change in date/center of examination under any circumstances. Students are advised not to canvass for such representation.
- 3.27.Admit Cards for FET 2024 Examination shall be available to download at NBEMS website https://natboard.edu.in on 19th February 2025. Students found ineligible shall not be issued admit cards.
- 3.28.Result of FET 2024 shall be displayed on National Board of Examinations in Medical Sciences website https://natboard.edu.in
- 3.29.FET 2024 shall be conducted by NBEMS at various exam centres engaged for the purpose. Students are advised to familiarise

- themselves with the route and location of the exam centre. Please refer the chapter on Test Day Procedures for further details.
- 3.30. The examination test centre staff on duty is authorized to verify the identity of students and may take steps to verify and record the identity of students. Students are required to extend requisite cooperation.
- 3.31.Possession/Use of mobile phones/Electronic devices is strictly prohibited in the premises of NBEMS test Centres. Students shall be liable for penal action for Possession/ Use of Mobile phones/ Electronic devices. Please go through guidelines detailed in the chapter on unfair means in the examination.
- 3.32.**Demo Test:** A demo test shall be available for the benefit of students to familiarise themselves with the Computer Based Test format at website https://natboard.edu.in Students will be able to access the Demo test from **4th February 2025 onwards**.
- 3.33. The students should communicate with National Board of Examinations in Medical Sciences regarding matters related to FET 2024 as per prescribed Protocols only, detailed under **Chapter on Communication Protocols**.
- 3.34.Students are encouraged to communicate through Communication Web Portal with National Board of Examinations in Medical Sciences. All the correspondence through post should be addressed to the Executive Director, National Board of Examinations in Medical Sciences, Medical Enclave, Mahatma Gandhi Marg, Ansari Nagar, New Delhi-110029. Students are requested to superscribe the envelope with the subject matter of the correspondence for expeditious processing.
- 3.35.The jurisdiction for court cases/disputes shall be at New Delhi only.

4. Examination Fee

- 4.3. Applications forms once submitted cannot be withdrawn. Fee shall neither be carried forward to a future date nor refunded under any circumstances. Application once submitted cannot be withdrawn. Any claim for refund, adjustment or carrying forward of Application fee will not be entertained.
- 4.4. **How to pay:** The prescribed exam fee should be remitted through payment gateway provided using a Credit Card or a Debit Card issued by banks in India or other modes as may be made available and have been provided on the web page. Fee can not be deposited through any mode other than the payment gateway available while submitting online application form submission.
- 4.5. Examination fees in respect of students who are absent or have been declared ineligible due to any reason will be forfeited. Students are advised to read the information bulletin for FET 2024 carefully and satisfy the terms and conditions for fulfilment of eligibility criteria before proceeding for payment of fees.
- 4.6. Kindly ensure that the payment made for examination fee is successful and confirmation of the same can be seen in the

application form under payment status reflected as "S" (for successful). In case the status is shown as pending, the payment might be stuck with your bank and might be cleared at a later date. The application submission process in not completed till such time the status of payment is reflected as "s" in application form. NBEMS shall not be responsible for rejection of your application due to delay in settlement of the payment by your bank to NBEMS.

4.7. It is at the discretion of the applicant to make another payment for completing the application submission process. In an event of receipt of duplicate/multiple examination fees towards the same application ID, NBEMS shall refund the excess fees received for an application retaining the prescribed examination fee, after closure of application window.

5. Eligibility Criteria

A. For Indian Students:

The student must meet/fulfil the following criteria:

- 5.1. Students who are in possession of recognized post graduate medical Degree/Provisional Pass Certificate (MD/MS/DM/MCh/DNB/DrNB) or an equivalent recognized qualification or likely to be in possession of the same by **31st December 2024** in accordance with eligible feeder qualifications for Fellowship courses as mentioned in **Annexure B** of this Information Bulletin can apply for FET 2024.
- 5.2. Students found to be ineligible at any stage of FET 2024 will not be permitted to appear in the examination. In an unlikely event of any ineligible student appearing and/or being successful in FET 2024, the result/ candidature of such student shall be cancelled and/or is deemed to be cancelled as and when the ineligibility is detected.
- 5.3. The cutoff date for qualifying MD/MS/DM/MCh/DNB/DrNB qualification towards determination of eligibility for appearing in FET 2024 shall be **31st December 2024**.
- 5.4. Requests for appearing in FET 2024 from students who are qualifying and/or getting the results of their MD/MS/DM/MCh/DNB/DrNB qualifications after **31st December 2024** shall be summarily rejected.
- 5.5. Registration with NMC/State Medical Council is mandatory and its documentary proof should be furnished at the test Centre on the examination day.
- 5.6. Eligibility of students issued admit card for the examination shall be purely provisional and shall be determined at the time of admission/registration to the course. Appearing in FET 2024 does

not confer any automatic rights upon the student for admission to FNB courses.

5.7. There is no upper age limit for training in NBEMS Fellowship courses.

B. For International Students:

The student must meet/fulfil the following criteria:

- 5.8. The student should possess post graduate medical qualification equivalent to the eligible feeder qualification as mentioned in the **Annexure B** of this Information Bulletin for the corresponding Fellowship course.
- 5.9. The cutoff date for qualifying the eligible feeder post graduate medical qualification towards determination of eligibility for appearing in FET 2024 shall be **31st December 2024**.
- 5.10. The qualification of the student should be a registered qualification in his /her own country. The qualification of the student should be a recognised qualification as per provisions of the NMC Act, 2019 and included in Second Schedule or Part II of Third Schedule of the Indian Medical Council Act, 1956 which can be seen at the official website of the NMC.
- 5.11. The student should be a registered medical practitioner in his/her own country.
- 5.12. Foreign Nationals desirous of appearing in FET and those, who are required to have security clearance as per the Ministry of Home Affairs (MHA) requirements, shall obtain the security clearance from Ministry of Home Affairs, Govt. of India. Such eligible students who would qualify the entrance examination shall have to produce the clearances so obtained from appropriate authorities

(Ministry of External Affairs, Ministry of Home Affairs, Local police) for seeking temporary registration with the National Medical Commission before they are permitted to join any FNB course.

- 5.13. The National Medical Commission may, on payment of the prescribed fee for registration, grant temporary registration for the duration of the Post Doctoral course limited to the medical college/institution to which he/she is admitted for the time being exclusively for pursuing postdoctoral studies. Provided further that temporary registration to such foreign national shall be subject to the condition that such person is duly registered with appropriate registering authority in his/her own country where from he/she has obtained his/her PG Medical qualification, and is duly recognized by the corresponding Medical Council or concerned authority.
- 5.14.A visa support letter shall be issued by NBEMS to facilitate appropriate and valid travel visa and travel medical insurance.
- 5.15.All international students are required to obtain a "No Objection Certificate" from their Medical council /Government for appearing in the examination and permission for working in India for the period of Fellowship based on valid travel document (passport) and valid permission (visa). The documents shall be required to be produced at the time of counseling.
- 5.16. Eligibility of students issued admit card for the examination shall be purely provisional and shall be determined at the time of admission/registration to the course. Appearing in FET 2024 does not confer any automatic rights upon the student for admission to FNB courses.
- 5.17. There is no upper age limit for training in Fellowship courses.


6. Scheme of FET 2024

- 6.1. The selection of a student will be through a MCQ based examination namely Fellowship Entrance Test.
- 6.2. The list of Fellowship courses offered to Indian and International Students through FET 2024 can be seen at **Chapter 2.** The prior entry qualifications i.e. feeder qualifications eligible for a particular fellowship course are detailed in **Annexure B** to this information bulletin.
- 6.3. **Scheme of FET 2024**: A student can apply for the fellowship courses for which his/her broad or super specialty qualification/ equivalent qualification is eligible, at the time of online submission of the application form.
- 6.4. The total duration of the question paper will be 105 minutes (Part A 45 minutes and Part B 60 minutes).
- 6.5. **Question Paper:** There shall be a separate question paper for each fellowship course /clubbed group. Total number of questions in each question paper shall be 100 which shall be divided into two Parts; Part A & Part B.
- 6.6. **Part-A of the question paper** for any fellowship course/clubbed group shall comprise of MCQs from the eligible feeder broad/ super specialty course(s). In case, there is only a single feeder broad specialty course for a particular super specialty, Part A in such a case will comprise of questions from only one broad specialty. For eg. MS/DNB General Surgery is the only feeder specialty for FNB Minimal Access Surgery, therefore Part A of FNB Minimal Access Surgery question paper will comprise of questions from General Surgery.

For Fellowship courses having multiple feeder specialty courses, Part-A will comprise of questions from all the eligible feeder

specialty courses. For eg. The eligible feeder specialties for Hand & Micro Surgery course are General Surgery, Orthopaedics and Plastic Surgery. Therefore, Part -A of Hand and Micro Surgery question paper shall comprise of questions from all the three feeder specialty courses i.e. General Surgery, Orthopaedics and Plastic Surgery.

6.7. **Part- B of the question paper:** It shall comprise of 60 questions pertaining to the concerned fellowship course. The questions shall shall cover topics from clinical practice and basic sciences as applied to the concerned Fellowship course at entrance/entry level.



6.8. **Clubbing:** Certain Fellowship Courses have been clubbed together and each clubbed group of Fellowship Courses shall be treated as one for the purpose of online submission of the application form and generation of the question paper. For eg. Spine Surgery, Sports Medicine and Arthroplasty Fellowship Courses have been clubbed together and all these

clubbed Fellowship courses will be treated as a single unit for the purpose of online submission of application form and examination. Therefore, part A of the question paper for the clubbed super specialties shall comprise of questions from the eligible feeder specialty(s) only and the part B shall comprise of equal number of questions from all the clubbed Fellowship Courses. A student can opt for only one Fellowship course/clubbed group at the time of online submission of the application form based on his/her eligibility for the concerned Fellowship course.

7. Admit Card & Test Day Procedures

- 7.1. Admit Card: Admit cards shall be made live on National Board of Examination website https://natboard.edu.in on 19th February 2025. Admit cards will not be issued to students found ineligible.
- 7.2. Students will be informed through SMS/Email alerts and website notice regarding availability of the admit card on National Board of Examinations in Medical Sciences website. Admit card will not be sent to the students by Post/Email.
- 7.3. Students are required to download their admit card from the NBEMS website and affix firmly their recent (not more than 3 months old) passport size photograph in the space provided on the admit card. The photograph must meet following specifications:
 - Size of photograph: Minimum 35x45 mm (and not larger than the box printed on admit card for pasting the photograph) with at least 75% area on the photograph should be occupied with the face & head of the candidate.
 - It should be a Colour photograph with white background
 - The photograph needs to display full front view of the face with a neutral expression. No Caps, Stethoscope, Goggles, Ornaments to be worn.
 - The photograph should not have reflection or shadow on the face with red eyes.
 - The photograph needs to be printed on a high quality paper with at least 600 dpi Resolutions.

- The photograph must not have kinks, scratches and stains.
- 7.4. **TEST DAY PROCEDURES:** NBEMS will conduct **Computer Based Test** in safe and secure environment. NBEMS reserves its rights to review the test day processes of conduct of CBT.
- 7.5. Entry of Students as per Timelines given in the Admit Cards: Students are required to report at the 'Reporting Counter' of test venue as per time indicated in their admit cards. The exact entry point to the test centre (Reporting Counter) and the main gate of venue might be at a distance. To avoid unforeseen delay in reaching to the test centre entry point (Reporting Counter), Students are advised to reach well in time and familiarise themselves with the exact point of the entry to test centre in the premises of the venue well in advance. The reporting counter will close 30 minutes prior to the test start time. Any delay in arrival to the test centre entry point (Reporting Counter) shall lead to denial of entry even if the candidate might have arrived to the premises of venue.
- 7.6. Students reporting late or beyond the prescribed time shall not be allowed to appear in the exam under any circumstances. NBEMS shall not be responsible for any delayed arrival of the student in reaching the centre due to any reason.
- 7.7. **Test Centre Location:** Exact address and location of the test centres shall be indicated in the admit card. Students are advised to familiarise themselves with the test centre locations at least one day prior to the examination day and ensure that they report for the exam as per scheduled time only. Google map location shall be indicated in the admit card for quick reference only. It shall be the responsibility of the candidate to confirm the exact location of the test centre well in advance to avoid any delay in arrival.

- 7.8. Please note that only the students who have been issued admit card will be allowed entry inside the examination centre premises subject to fulfilment of documentary requirements.
- 7.9. Friends or relatives accompanying the students will not be allowed entry in the examination centre premises under any circumstances and will not be allowed to contact the student while the examination process is ongoing.
- 7.10.Barcode/QR Code Reader at Entry Points: The student will flash the admit card and ID proof for verification to the exam functionary standing across the table with barcode/QR code reader. Student shall be informed about the assigned lab number. Alternatively, the list of Roll numbers and assigned labs shall be displayed outside the test venue.
- 7.11. Identity checks will be made upon arrival at the test centre to ensure that there are no unauthorized students appearing for the exam.
- 7.12.Students MUST bring to the test centre the following documents: 7.12.1.Printed copy of Barcoded/QR Coded Admit card
 - 7.12.2.Photocopy of Permanent SMC/MCI/NMC registration, to be retained by the test centre &
 - 7.12.3.Any one of the below mentioned Govt issued photo IDs** (must be **original** and **valid/non-expired)**:
 - PAN Card
 - Driving License
 - Voter ID
 - Passport
 - Aadhaar Card (with Photograph)

International Students shall carry their Govt issued Passport at Test Centres (must be **original** and **valid/non-expired).**

- 7.13.In case, any candidate reports to the test center with e-Aadhaar Card with Aadhaar number printed on it or e-PAN card with PAN number printed on it as proof of identity, the e-Aadhaar Card/e-PAN should be a good quality colour print out with clearly visible photograph. The photograph should not have kinks, scratches and stains, and should definitely match with the candidate presenting the e-Aadhaar Card/e-PAN. Decision of NBEMS in this regard shall be final".
 - ** The name on the photo identification must match with the name as shown on the Admit Card. If name has changed due to marriage etc, candidate must show the relevant document to substantiate claim for change in name (Marriage Certificate/Divorcee Decree/ Legal Name Change Document/ Gazette notification for name change). In case of Mismatch in name between admit card and Photo ID proof shown, entry shall not be allowed.
- 7.14. Students without **original hard copy valid ID** proof shall not be allowed to enter the examination premises. Photocopies of Govt. issued ID proofs shall not be accepted. Identity proof shown in DigiLocker shall also not be acceptable as Students shall not be allowed to carry electronic devices inside the exam centre.
- 7.15.Unfair means case shall be registered against the students producing false/forged documents/ID Proofs.

7.16.**SECURITY AT THE TEST CENTRE: SECURITY AT THE TEST CENTRE:** Students will **not be allowed** to take the following items **beyond security check point** in examination premises under any circumstances:

• Any stationery item like textual material (printed or written), notes, Plastic Pouch, Calculator, Pen, Writing Pad, Pen Drives, Eraser, etc..

- Any electronic device like Mobile Phone, Bluetooth, Earphones, Microphone, Pager, wrist watch/Health Band/Smart Watch, Calculator, Electronic Pen/Scanner etc.
- All ornaments like bracelets, Ring, Ear rings, Nose-pin, Chain/ Necklace, Pendants, Necklace with pendants, Badge, Brooch etc. Ornaments/ items worn out of specific religious beliefs shall only be permitted after thorough verification.
- Other items like Wallet, Goggles, Handbags, Belt, Cap etc.
- Any eatable item opened or packed, soft drinks, water bottle etc.
- Any other item which in discretion of exam functionaries could potentially be used for unfair means, for hiding communication devices like wireless/Bluetooth device, spy camera etc.
- 7.17.Students will be permitted to carry certain items with them to the examination lab:
 - Admit Card
 - Govt issued photo identification proof (Voter ID/ PAN Card/ Aadhaar Card/ Passport/Driving License)

Please read the admit card carefully for items permitted to carry inside the examination centres.

7.18.No arrangement will be made at the centres for keeping any articles/items belonging to the students. In case any student is found in possession of any of the barred items inside the centre beyond the security check point, it will be considered as use of unfair means and action will be taken against the student in accordance with the relevant provisions. To avoid any hardship students are advised not to bring prohibited items along with them at the test Centre.

- 7.19.Frisking (Body pat as well as HHMD) will be done at the entrance of the test centre secure zone.
- 7.20. Finger Biometrics of Students shall be captured at the time of registration for the test at test venue in CBT. In addition, Photograph of the Students shall also be captured on the exam day at the centre at the time of registration, at each bio-break and during the exam. Face ID shall be verified at the time of collection of FMGE Pass Certificate, against the photograph(s) captured on the exam day and photograph(s) uploaded in the application from. Therefore, it is essential to upload a recent photograph in the application as per image upload guidelines prescribed, in order to avoid mismatch in Face ID verification process. Students are requested to cooperate with this essential activity to avoid any cases of impersonation. This is a security feature which will ensure that only genuine candidate appear for the exam. Any candidate not adhering to the aforementioned security measures will not be allowed to take the test. Manual Attendance with signature and manual thumb impression shall also be done.
- 7.21.After verification of ID and capture of Face ID, students will be escorted to the designated computer terminal at the test centre ensuring social distancing and a Invigilator will assist the student for check-in process of the test.
- 7.22.Students are required to keep their admit card and photo identification with them at all times during the conduct of examination.
- 7.23.Students are required to listen to the invigilator's instructions to begin the exam. Each workstation will be blocked from three sides front, left and right. Students are advised not to look around at other students as there will be surveillance cameras also that will record video.

- 7.24. Any suspicious or disruptive behaviour on part of the student may lead to cancellation of candidature. For any issues during the exam, student may raise his or her hand to notify Invigilator.
- 7.25.Manual Attendance with signature and thumb impression shall be done during the examination.
- 7.26. In case of any technical disruption during the test, rest assured that a registered student will get complete allocated examination time. The technical issues, if any, shall be attended by the authorised staff on examination duty as detailed under:

7.27.Should you need to carry any medicine or a medical assistance device at the exam centre, please carry supportive medical documents. In absence of such documents, you shall not be permitted to carry such devices/ prosthesis/ medicine etc. Should you require any assistance of scribe, please seek prior approval of NBEMS by way of submitting a query at NBEMS Communication Web Portal along with documents in support as per provisions of RPwD Act, 2016. Information about requirement of Scribe and/or Compensatory time needs to be mentioned in application form also. In absence of prior approval of NBEMS, you shall not be allowed to accompany a scribe with you inside the exam centre.

- 8.2. The exact venue will be informed to the students through admit cards. The Students shall make their own arrangement for travel/boarding etc.
- 8.3. At the time of online submission of application form, the student will be required to choose the city in which he/she wants to take the test. The choice of city will depend on availability of the test centres in a particular city and the allotment shall be done on first come first serve basis.
- 8.4. During submission of online application form, student will be able to see only those cities where testing seats are available. While the city will be chosen by the student himself / herself at the time of online submission of application form, allotment of test centre/venue in the chosen city shall be done by NBEMS.

- 8.5. In case testing seat is not available in the State/UT in which the candidate prefers to appear in FET, he/she can choose the option OTHERS from the list of States/UTs at the time of selection of the State/UT during online submission of application form. Candidate opting for OTHERS must note that though NBEMS will make all efforts to allot a testing centre in the State of correspondence address of the candidate, however, in case of unavailability of testing seat in the concerned State due to logistic, administrative or other reasons, testing centre anywhere in India may be allocated. Students opting for OTHERS option shall be informed about their testing city through email.
- 8.6. In case testing seat is not available in the State/UT in which the candidate prefers to appear in FET 2024, and the candidate choses some other available city instead of choosing the option "OTHERS", the choice of city will not be changed at later stage and the candidate will be required to take the test in the city chosen by him/her.
- 8.7. The list of test cities is purely tentative. In an extraordinary situation where a test city mentioned in the information bulletin could not be considered for conduct of examination due to security audit issues at test centre(s) in that city or other logistic issues/unforeseen reasons, Students who would have indicated choices for such test cities shall be accommodated in other available nearby cities. The test city allocated shall be intimated through email in advance to concerned Students. NBEMS may add a new test city which is not indicated in the bulletin if so required to accommodate the Students. NBEMS reserves its right to allocate test centre anywhere in the country irrespective of the test city chosen by the candidate to maintain the sanctity of examination.
- 8.8. Students will be informed regarding their test venue through the admit card. Requests for change of testing centre / city shall not be entertained. Students are advised not to canvass for the same.

9. Instructions to Fill Online FET 2024 Application Form

- 9.1. **New User Registration:** All students desirous of applying for FET 2024 shall be required to create an online profile of themselves to generate a UserID and Password.
- 9.2. **Applicant Login:** This User ID and Password so created will allow the student to login as an applicant for FET 2024 and register an online application. The "Go To Application" link will allow the student to continue with the application submission immediately after user creation.
- 9.3. If the Login password is lost, it can be retrieved by clicking "Forgot Your Password".
- 9.4. Name of Candidate: Please mention your full name as in Post Graduate Medical Qualification Certificate. Name as entered by the candidate while creating his/her User ID shall be reflected in a non-editable format in his/her examination application form. No change in the name shall be permissible under any circumstances after submission of an application. The candidate shall be required to produce his/her Govt issued ID proof bearing same name at the test centre on the test day to seek entry. In case of Mismatch in name between admit card and Photo ID proof shown, entry to the test centre shall not be allowed. It is strongly advised not to submit an application with an error in the candidate's name as it shall not be allowed to be edited after application submission. If the user has entered his/her name wrongly while registering the user, please create another user with correct name.
- 9.5. **Gender and Date of Birth:** Indicate your gender and Day, Month & Year of your birth. Please enter the correct date of birth carefully while registering the user..

- 9.6. Nationality: Nationality: Please choose your nationality amongst the options given: Indian, Non-Resident Indian (NRI), Overseas Citizen of India (OCI) and Non OCI Foreign Nationals. Indian Citizens who are not NRI should choose Indian. An Indian Citizen should choose Non-Resident Indian, if he/she is an NRI. If you are a Foreign National but also an Overseas Citizen of India (OCI), please choose OCI. Foreign Nationals who are not an OCI should choose Non OCI Foreign National.
- 9.7. Email ID: Email ID chosen by the student shall be verified through a system generated OTP for user creation. Same email ID can not be used for registration of any other user concurrently. Please note that all email correspondence with the student shall be done at this email ID only. Email chosen by the student shall be the primary means to communicate with the student for examination purposes. Information related to examinations shall be sent at this email ID. Students shall also be able to communicate with National Board of Examinations in Medical Sciences through this registered email only. Correspondence received from any other email ID of the student shall not be entertained. Therefore, students are advised to choose the email ID carefully.
- 9.8. **Mobile No**: Please provide a unique mobile number for receiving Examinations related communications sent through SMS. Mobile number chosen by the student shall NOT be the primary means to communicate with the student for examination purposes.
- 9.9. The UserID/Application ID and password so generated shall be sent to the registered email ID of the student for future records.
- 9.10.The index page of FET 2024 at National Board of Examinations in Medical Sciences website https://natboard.edu.in provides a quick link, "Applicant Login". The online application form for FET 2024 can be accessed through this quick link after successful login.
- 9.11. The student can login using his/her User ID and Password.

- 9.12.The application submission process can be completed either in a single sitting or in multiple sittings, as per the student's choice, during the application submission window. However, once an application is successfully completed & submitted, it shall be available for editing certain field only during the "edit window".
- 9.13. Students are advised not to complete & submit their online application in a haste so as to avoid any errors in providing information. Request for making any changes in date of birth, name or any other information provided in the application shall be summarily rejected. NBEMS does not edit/modify/change any information provided by the Students in their applications of its own. Students has the option to make corrections in any information except name, nationality, test city, mobile number and email ID during the edit window.
- 9.14. The student shall be required to provide information as asked under various heads. It is strongly recommended to keep the required information handy before start filing the application. Some of the salient heads in the application form are as under:
- 9.15. Upload of Prescribed Images (Photograph, Scanned Signatures and Thumb Impression): Please refer Image Upload Instructions available at NBEMS website https://natboard.edu.in and at the end of this information bulletin for details of specifications for uploading photograph, signatures and thumb impression. Images which are not as per prescribed specification shall not be considered and may lead to rejection of the application. Please ensure that uploaded photograph is a RECENT photograph and in any case should have not been taken more than 3 months before the date of application submission. Uploading a photograph which is not a recent one or which is not as per prescribed image upload guidelines as detailed in this information bulletin and/or failure to rectify the same in the final edit window shall invite rejection of the application.

- 9.16.The test city can be selected from available choices **on first come first serve basis.** While the city will be chosen by the student himself / herself at the time of online submission of application form, allotment of test centre/venue in the chosen city shall be done by NBEMS.
- 9.17. After selection of test city, the student shall be required to pay the prescribed examination fee online. The fee can not be paid through any mode other than the payment gateway available in online application form.
- 9.18.Students shall be prompted to preview the entire application before submission in order to make any corrections, if so required. They shall be required to submit the application after agreeing to the "declaration". This shall complete the entire process of application submission.
- 9.19.**Acknowledgement of Application Submission:** An acknowledgement email shall be sent to the registered email ID confirming submission of an application by the candidate. Submission of application shall be completed only after successful payment of examination fee. Candidate should confirm the status of payment in the application form PDF where 'S' would stand for "Successful" and "F" would stand for "Failed".
- 9.20.**Edit Window:** Students who have successfully submitted payment for their application during Application Submission window shall only be allowed to edit their applications during **20th January 2025 to 22nd January 2025.** No new application can be registered during edit window or payment can be made during the window. Any information/document can be changed/corrected during the edit window except for Name, Test City, Nationality, mobile number and Email ID. Information can be edited any number of times before the closure of the window. The last submitted information will be saved in records.

- 9.21.All *editable fields* in the application form shall be open for the student to make any corrections, if so required. Details of field which can not be edited are mentioned below.
- 9.22.Information entered in the application form can be changed during the "Edit Window". **However, following fields in the application form shall remain non-editable:**
 - Name of the Student
 - Email ID
 - Mobile Number
 - Nationality
 - Test City
- 9.23.No editing in information provided shall be permissible in the application form, once edit window is over. NBEMS disclaims any liability that may arise due to incorrect information provided by the student during online application form submission.
- 9.24.NBEMS does not edit /modify/alter any information on its own which is entered by the students at the time of online submission of application form, under any circumstances.
- 9.25. Selective/Final Edit Window: Subsequent to closure of edit window, deficiency, if any related to images uploaded, in the application form shall be communicated to concerned Students. The corrections in images uploaded (i.e. Photographs, Signatures and Thumb impression), if required, shall be communicated through emails at registered email ID of concerned Students only. and same can be corrected during the final edit window i.e. 31st January 2025 to 3rd February 2025. Only those images which require corrections shall be editable during this final edit window. No further opportunity shall be given to make corrections. Students are advised to submit the images in their application as per prescribed image upload guidelines. Failure to submit images as

- 10.10. Violation of any act or breach of the same shall be liable for penal action and cancellation of the candidature at the bare threshold.

C. Unfair Means

If during the course of training/examination, a student is found indulging in any of the following, he/she shall be deemed to have used unfair means.

- 10.11.If a student is found to have made a wrong statement in his/her application form for appearance in the examinations / counseling / admission to the training or has attempted to secure or has secured admission to any of the examinations/courses of NBEMS or has obtained registration with any medical council, by making a false statement or by production of a false/forged document.
- 10.12.If at any stage a student has tampered with any entry in the certificate or statement of marks or any certificate issued by any governmental or non-governmental body or any other document that has been issued to him/her by NBEMS.
- 10.13.Use/possession of any kind of electronic gadgets including mobile phones with or without internet (whether the gadgets are actually used or not).
- 10.14. A student found copying from notes written on any part of his/her clothing, body, desk or table or instrument like setsquares, protractors, scales etc. or who is found guilty of concealing, disfiguring, rendering illegible, swallowing or destroying any notes or papers or material found with him/her or found exchanging answer book or question paper with solution or talking to a person or consulting notes or books outside the Examination Hall, while going to the toilet or in the toilet.
- 10.15. Giving or receiving assistance directly or indirectly of any kind or attempting to do so.
- 10.16. Having in possession of any note-book(s) or notes or chits or any other unauthorized material concerning the subject pertaining to the examination paper.

- 10.17.Change of seat/system without the permission of Examination Superintendent/ In charge Computer Laboratory.
- 10.18.Contacting or communicating or trying to do so with any person, other than the Examination Staff, during the examination time in the examination center/ Computer Laboratory.
- 10.19. Consulting notes, books or any other material or outside person while going out of the examination hall/Computer Laboratory to toilet or to any other place.
- 10.20.Impersonation.
- 10.21. Forgery in photo identification produced to seek entry in the test centre/producing false documents for the purpose.
- 10.22.Using or attempting to use any other undesirable method or means in connection with the examination.
- 10.23. Smuggling out Question Paper or its part; or smuggling out answer book/ supplementary answer sheet or part thereof.
- 10.24.Running away or swallowing or destroying any note or paper or material found with him/her.
- 10.25.If the answer books show that a student has received or given help to any other student through copying.
- 10.26. Threatening any of the officials connected with the conduct of the examinations or threatening of any of the students.
- 10.27. Found exchanging answer book or question paper with solution or copying from unauthorized material.

- 10.28. Peeping into the computer monitor screen of the other student.
- 10.29.Disclosing his/her identity or making distinctive mark in the answer book for that purpose or fails to deliver his/her answer book/continuation sheet before leaving the examination hall.
- 10.30.Hacking or attempting to hack or causing interference with the website of NBEMS or its Technology Partner(s) or their Information Technology systems.
- 10.31.Tampering with Information Technology systems of NBEMS or Technology Partner(s) or Computer Laboratory.
- 10.32. Damaging the computer systems of computer Laboratory.
- 10.33.Students found to have attempted or trying to attempt personally or through another person to influence or pressurize an examiner, or any officer or official connected with the examinations of the NBEMS or its technology partner, either at NBEMS or at the office of technology partner or their respective residence(s), in any matter concerned with the examinations.
- 10.34. Any student violating the NDA as detailed above will be treated as UMC.
- 10.35.If at any stage if it is found that the student has appeared multiple times in the same session of examination or has appeared in same or different examination of NBEMS with different names, unfair means case shall be registered against such student and dealt accordingly.
- 10.36.Any act of student/any person which is detrimental to safe, secure and smooth conduct of examination and the decision of EEC in this regard shall be final.

- 10.37.Student is found talking/peeping to another student during the examination hours in the examination room.
- 10.38.A student who refuses to obey the Superintendent of Examination center/Computer Lab and changes his/her seat with another student and/or creates disturbance of any kind during the examination and/or otherwise misbehaves in the examination hall.
- 10.39. Any student found guilty of having adopted anyone or more of the above Unfair means/misconduct is liable to be penalized with a penalty by the Examination Ethics Committee, which may vary from cancellation of the examination/ expulsion up to next 14 attempts or 7 yrs and/or cancellation of candidature as may be decided by Examinations Ethics Committee after considering each case.
- 10.40.**Disclaimer:** The above list is purely indicative. If any act of omission or commission attributed to the student/intent by the student to vitiate the sanctity of the examination, the decision of NBEMS shall be final and binding for declaration of any person/student guilty of foregoing or such offence as shall be classified as UMC.

11. Result & Counseling

11.1.QUALIFYING CRITERIA:

Students who obtain minimum of **50**th **Percentile** in their respective question paper / specialty shall be declared as "Qualified".

11.2. DATE OF DECLARATION OF RESULT:

The result for FET 2024 will be declared by **21st March 2025** The result shall be available at NBEMS website https://natboard.edu.in

- 11.3. Before declaration of the result, any question asked in the FET 2024 can be challenged for technical errors, if any, with supportive medical literature, in not more than 2 calendar days after conduct of examination (i.e till 25th February 2025). No claims made beyond 2 days of conduct of examination shall be entertained under any circumstances. No claims pertaining to the difficulty level of a question shall be entertained. Such challenge can only be raised by bonafide Students who had appeared in the examination through their registered email ID at Communication Web Portal of NBEMS.
- 11.4. The score card shall be available for download to the students through applicant login using NBEMS ID and Password.
- 11.5. There will be **NO** re-evaluation or rechecking or re-totaling. Requests for re-evaluation / re-totaling shall not be entertained.

11.6. VALIDITY OF FET 2024 RESULT

The validity of the result of FET 2024 shall be only for the current admission session i.e. 2024 admission session for NBEMS

Fellowship (FNB) courses and cannot be carried forward for the next session of admissions for FNB courses.

- 11.7. TIE BREAKER CRITERIA: In the event of students obtaining the same score for a particular fellowship course, the following tie-breaking criteria will be applied to determine inter-se merit in descending order of application till a unique inter-se merit is determined for all such students:
 - A. Student having **lesser number of negative responses in the overall paper** will be placed at higher merit position.
 - B. Student obtaining **higher score in Part B of the question paper** will be placed at higher merit position.
 - C. Student having **lesser number of negative responses in Part B** of the question paper will be placed at higher merit position.
 - D. Older student will be placed at higher merit position.
 - E. Candidate securing **higher aggregate marks** (in **percentage) in all MBBS Professional Examinations** will be placed at a higher merit position
- 11.8.PUBLICATION OF MERIT LIST: NBEMS shall declare specialty wise merit list i.e. there will be a separate merit list for each fellowship course. There shall not be any equating/scaling and normalization. The merit shall be generated strictly on the basis of marks obtained by the student and application of the prescribed tie breaking criteria. There shall be a separate merit list for Fellowship Programme for International Students (FPIS), in each specialty.
- 11.9.COUNSELING: The admission to Fellowship courses in the accredited hospitals shall be undertaken solely on the basis of

merit based counselling conducted by NBEMS. Details of counselling process shall be notified in due course after result of the entrance examination has been declared.

11.10.AVAILABILITY OF FNB SEATS FOR 2024 ADMISSION SESSION

Students may visit website of National Board of Examinations in Medical Sciences website https://natboard.edu.in for FNB seats accredited in various institutions across the country. However, the accredited seats shown on the website should not be treated as seat matrix for FET 2024 counseling. The final seat matrix of FNB seats going to be offered for 2024 admission session shall be published on NBEMS website before conduct of FET 2024 counseling.

The tentative list of institutions offering Fellowship Programme for International Students for 2024 admission session is placed at **Annexure - C.** The list is purely indicative. The final seat matrix shall be published on NBEMS website before conduct of counseling.

11.11.DOCUMENTS REQUIRED TO BE PRODUCED AT THE TIME OF COUNSELING

- MD/MS/DNB/DM/MCh/DrNB Degree Certificate/Provisional Pass Certificate of eligible Post Graduate Medical Qualification issued on or before 31st December 2024.

- "No Objection Certificate" from their Medical council /Government for appearing in the examination and permission for working in India for the period of Fellowship.

Temporary Registration with the National Medical Commission, New Delhi, India for the duration of FNB course shall be required to be obtained on allotment of a FNB seat.

- 12.7.Do not send the same query multiple times, as it will delay the response process.
- 12.8.Queries shall not be entertained from persons claiming themselves to be representative, associates or officiates of the candidate.

13. TRAINING

13.1. Selection of Students:

 NBEMS conducts Centralized Merit Based Counseling for admission to FNB courses in every admission session as per time schedule notified by NBEMS at its website. Details of conduct of counseling viz mode (Online/Offline), eligibility, schedule, seat matrix, venue, fee, procedure etc are notified time to time on NBEMS website.

13.2. Joining of Students:

- Each selected student shall be given a prescribed time from the date of issuance of the allotment letter to report and join the allotted NBEMS accredited Medical College/Institution/Hospital.
- Student has to begin his/her Fellowship training as soon as he/she join the institute. Accredited hospital/institute is required to submit the joining report of each student to NBEMS in prescribed proforma.
- Joining of a student to NBEMS accredited institute through Centralized Merit Based Counseling is subject to medical fitness of the student as assessed/examined by the accredited hospital/Institution. The medical examination of the student shall be done by the Medical Board of the concerned NBEMS accredited institute. Student found fit in the medical examination shall only be allowed to join FNB course. NBEMS reserves its rights to take a final decision in the matter of the student being found unfit in medical examination and may undertake medical examination of student at its sole discretion.

13.3. Academic Programme:

- Residency Guidelines: The institute will ensure that all the necessary training facilities and infrastructure is provided for implementation of FNB curriculum in the specialty.
- The FNB training is a residency based training cum employment programme wherein the FNB trainee discharges the duties of a Senior Resident and undergoes a rigorous academic programme to enhance his knowledge and skills.
- For performance of clinical /hospital duties the trainees are required to discharge duties as may be prescribed by the hospital / institute administration. NBEMS shall not ordinarily interfere in any dispute which is a work place dispute or an issue involving the accredited institute and the FNB trainee(s). However, in rare or exceptional cases NBEMS may consider the issue for necessary action or adjudication.
- NBEMS reserves its rights to critically review the work allocation to the FNB trainees especially in reference to the implementation of academic programme and professional responsibilities. Record of duty roster of FNB trainees should be maintained for verification by NBEMS if so required.
- Academic programme for FNB trainees: Each accredited hospital shall publish a comprehensive academic programme for the specialties accredited. The design of the programme should be such that the entire course curriculum especially the protocol and clinical aspects are covered by way of seminar, symposia, general discussions, case base discussions, clinical examinations, OSCEs, bedside vivas, ward rounds, mock theory examinations, mock tests, grand vivas, final examinations, CMEs, workshops, guest lectures, e-learning, quizzes, group discussions etc. The record of academic sessions so conducted by the hospital shall be maintained by the hospital for verification by National Board of Examinations in Medical Sciences if so required.

- A copy of the academic programme so prepared and implemented by the accredited hospital shall be written in Log Book of the student that shall be duly authenticated by Head of Department /Head of Institution.
- Logbook: A log of academic activities indicating a daily record of academic work, thesis protocol, cases presented and procedures done under observation/independently, rotational postings undertaken etc shall be maintained by the trainee; signed and supervised by the designated guide of trainee and countersigned by Director/Medical Superintendent of the hospital. National Board of Examinations in Medical Sciences reserves its right to verify the logbooks of FNB trainees at any time during their training for its completeness and authenticity of information entered.
- Work Shops and CME: The accredited hospital shall relieve the student for:
 - Attending the workshops organised by NBEMS.
 - National conferences or state conferences of National Professional bodies in the concerned specialties.
 - International conferences in the concerned specialties.
 - Any other CME or workshop as may be deemed appropriate
- It is not obligatory on part of hospital/institute to relieve the trainee if the exigency of hospital duties so warrants.
- Such period of deployment to the above mentioned workshop / conferences shall be part of training and shall be governed by the applicable leave guidelines for FNB trainees.
- Each consultant who has been shown as faculty for FNB programme will devote at least 10 hour per week for teaching/ training in terms of case discussion, seminar, ward round, journal club etc. for FNB

trainees. This is in addition to his/her assigned clinical & other hospital responsibilities.

- The minimum teaching programme per week shall comprise of 5 hours of didactic teaching (Seminars, Journal Clubs, Lectures etc) and 5 hours of clinical/bed side teaching. Each consultant will have to attend NBEMS CMEs or faculty development workshops as conducted by NBEMS time to time.
- The accredited hospital shall maintain details of its full time faculty for DNB/FNB programme on its official website indicating their designations and time period of availability in the hospital.
- **Training in Basic Sciences:** The applicant hospital is required to make provisions for training & teaching of FNB trainee in applied basic sciences as relevant to the applicant specialty.
- The applicant hospital is required to arrange appropriate number of lectures/demonstrations/group discussions/seminars in applied basic sciences as relevant to the applicant specialty.
- As per NBEMS criteria the hospital should have one of the following provisions for applied basic science teaching & training:
 - A team comprising of in-house faculty from relevant surgical disciplines (such as General Surgery, Obstetrics & Gynaecology, Orthopaedics, Surgical Super Specialty etc) to provide applied anatomy teaching/training and faculty from relevant medical disciplines (such as General Medicine, Paediatrics, Medical Super specialties etc) to provide applied physiology & pharmacology teaching/training to the FNB trainees as applicable to the applicant specialty may be constituted. The biochemist, microbiologist & pathologist with PG degree qualifications in the hospital shall supplement the above team for applied basic science training, 'OR'

- Specialists in basic sciences can visit the applicant hospital as adjunct/guest faculty to impart the applied basic science teaching/training to FNB trainees of the applicant hospital as relevant to the applicant specialty, 'OR'
- A tie up with other institution (e.g. a medical or dental college/university/institute) may be undertaken to provide applied basic science teaching/training. A Memorandum of Understanding (MoU)/Permission letter from the Head of Institute of respective Medical or Dental College/University/ Institute should be submitted confirming to the said arrangement.
- Accredited hospitals should also rotate their FNB trainees for one month in each year (in addition to the routine duties) in their hospital's laboratory so as to enable them to gain knowledge in laboratory procedures related to Pathology, Histopathology, Biochemistry, Microbiology, Genetics etc.
- General Beds: The institute/hospital will earmark 30% of the beds in the specialty as "General (Teaching) Beds". General Beds are those 'earmarked' beds / cases whose patients shall be accessible at all times for supervised clinical work to FNB trainees. Data of patients admitted on such beds or such cases shall be accessible to FNB trainees for research purposes subject to applicable ethical guidelines and clearances from Institutional Ethics Committee & institutional policies. A certificate to this effect shall be furnished by the Head of Institute every year to NBEMS.
- Hands on Training: The accredited hospital /institution shall make use of a clinical skills lab /surgical skills lab in the state /city and arrange for such training as may be required for training of the students. The hospital shall provide such access to procedures (observed and supervised), assisted procedures to the FNB trainees as may be required for enhancing their competence and skills.

13.4. Formative Assessment Test (FAT)/ Appraisal of FNB Trainees:

- The hospital/institute shall ensure participation of FNB trainees in Formative Assessment Test organised by National Board of Examinations in Medical Sciences or by the hospital itself as per guidelines notified time to time on National Board of Examinations in Medical Sciences website https://natboard.edu.in
- The annual appraisal fee collected from FNB trainees shall be spent towards annual appraisal of FNB trainees only. The corpus cannot be re-appropriated/ utilized for any other kind of expenses. The fee applicable for Formative Assessment Test (FAT) organised by National Board of Examinations in Medical Sciences shall be transferred to NBEMS within stipulated timelines from aforesaid collection only.
- In the event the hospital/institute is found not complying with the appraisal guidelines/not participating in the appraisals/failed to transfer the fee to NBEMS as applicable for FAT, the hospital/institute shall have to refund the appraisal fees for said academic year to the trainee and further that penal action shall be taken by NBEMS against the hospital/institute.
- The accredited hospital shall relieve the FNB trainees for participating in FAT organised by National Board of Examinations in Medical Sciences. In his/her absence, the clinical duties may be assigned to the non-academic Junior/Senior residents in the department.

13.5. Comprehensive Leave Rules for NBEMS Trainees:

In supersession of leave rules for NBEMS trainees published earlier by NBEMS, the following rules shall be applicable with effect from 22.11.2024 on all NBEMS trainees:

1. Purpose:

The purpose of NBEMS Leave Rules is to establish guidelines and

procedures for managing leave for trainees registered with NBEMS (National Board of Examinations in Medical Sciences) to undergo PG medical training at NBEMS accredited institutions.

2. Eligibility:

Every programme of the NBEMS requires a mandatory period of training which must be completed in order to be eligible to take the Exit Examination. NBEMS trainees must take utmost care to complete their training well within the cut-off date in order to be eligible to take the Exit Examination.

3. Leave Entitlement:

During the period of training, candidates are entitled to avail leave only in the following terms:

- a) NBEMS trainees are entitled to a maximum of 30 days of leave per year of training, which is the *'eligible leave'* for each NBEMS trainee.
- b) In addition, a candidate is entitled to a weekly / duty off during his / her training.
- c) However, when a candidate is on leave, the weekly / duty off mentioned in sub clause (b) above will be included in the leave taken by the candidate. For eg: If a candidate has taken leave for 30 days, the weekly / duty off during these 30 days will be included as a part of the leave taken by the candidate. The candidate will not be entitled to deduct the weekly / duty offs during the said period and count them either towards training or towards leave in addition to the 30 days.
- d) Maternity/Paternity Leave: Maternity leave shall be granted to female trainees in accordance with Central or State Government policies applicable to the training institute. The Expected Date of Delivery (EDD)/ Date of Delivery (DoD) should fall within the

duration of maternity leave applied for. Further, in whichever States 6 months of maternity leave is permissible as per policies applicable there, it can be availed during 2 months prior to EDD to 6 months after DoD. Paternity leave for maximum 2 weeks can be availed by male trainees.

- e) There is no provision of extension of maternity leave beyond permissible period or grant of Child Care Leave (CCL) in the NBEMS training programme.
- f) Trainees must note that the grant of Maternity / Paternity leave or leave on any other account does not mean that their training shall not be extended on account of their absence during the period they are on leave. Candidates are entitled to the benefit only of 'eligible leave' i.e. 30 days per year for the purposes of their training and any other leave availed by them on any ground whatsoever shall lead to the extension of training. Candidates must also note that if as a consequence of extension, their training extends beyond the cut-off date prescribed in the respective Information Bulletin for the final examination, he/ she shall not be eligible to appear in the said final examination.
- g) No study leave whatsoever is permissible to the NBEMS trainees. The eligible leave of 30 days a year could be used for any purposes as may be required. However, the trainees are not permitted to take up any employment or enroll for any other academic course during the leave period.

4. Leave Application Procedure:

a) Eligible leave of 30 days per year shall be granted by the training institution at their level. Any leave over and above the 'eligible leave' of 30 days per year shall be forwarded through the training institution with its recommendations to NBEMS for consideration. Any request of leave over and above the eligible leave of 30 days shall be submitted to NBEMS by way of an

NBEMS Leave Application Form well in advance to obtain NBEMS approval before proceeding on leave. Leave requests must be supported with relevant documents as perguidelines detailed in the NBEMS Leave Application Form. The leave application form, duly endorsed by the training institution, *shall have to be submitted by the trainee to NBEMS*, only through NBEMS communication web portal before proceeding on leave.

b) Requests for post-facto approval of leave shall not be entertained and the trainee shall be considered on an unauthorized absence for such period.

5. Extension of Training:

- a) As explained in Rule 3 above, any leave availed by an NBEMS trainee other than the eligible leave (30 days per year) shall lead to extension of NBEMS training. This extension shall be equal to the number of days of excess leave availed by the trainees.
- b) The training period as prescribed in the letter of registration issued by NBEMS in terms of number of calendar days/month/years must be completed for successful completion of NBEMS training. Any extension, if so required to be undertaken due to excess leave availed in a year, can only be done by working for the number of days equal to the excess leave availed during the training programme.
- c) The extension of training period cannot be compensated by way of working extra hours on working days or by working on holidays or in any manner other than prescribed herein above.
- d) Eligible leave of one year shall not be carried forward to the next year or clubbed with the eligible leave of next year to calculate the total period of extension required to be undertaken. The leave remaining unutilized in a year shall lapse on expiry of the year. In *exceptional circumstances*, NBEMS may allow balance leave of one year to be credited against the

leave availed in next year(s) of training, on a case-to-case basis, to arrive at the period of extension required to be undertaken.

6. Considerations During Leave Period:

- a) Days for attending NBEMS Final Theory & Practical Examinations and Formative Assessment Tests will be considered towards period of training and not as leave.
- b) The trainees are paid stipend for the entire duration of training including their eligible leave as per NBEMS stipend guidelines. However, they shall not be paid stipend for a period more than the duration of the training programme i.e.36 months (for a 3-year programme) or 24 months (for the 2 year Programme) or 72 months (for the 6 year programme), if in case their training gets extendeddue to excess leave availed by them.

7. Compliance and Enforcement:

- a) Trainees are required to comply strictly with NBEMS leave rules and institutional policies.
- b) Failure to comply may result in disciplinary action, including cancellation of candidature.
- NBEMS trainee must be careful while applying for leave. They must take note that if the total leave availed by them during the training programme is more than a year, it shall lead to the cancellation of the candidature of the NBEMS trainee and shall disentitle him/her from pursuing the NBEMS programme. Candidates must therefore ensure that the leave taken by them must under no circumstances exceed a year.
- d) Any absence from the training that is not in accordance with the present Rules shall amount to Unauthorized Absence and such absence from NBEMS training for more than 7 days *may* lead to cancellation of registration and discontinuation of the NBEMS training.

- e) If on account of the leave taken by the NBEMS trainee, his/her training have been extended beyond the cut-off date prescribed in the respective Information Bulletin for the final examination, he/she shall not be eligible to appear in the said final examination. NBEMS trainees must therefore keep this in mind while taking leave from the training programme.
- f) The eligibility for DNB/ DrNB/ FNB/ NBEMS Diploma Final Examination shall be determined strictly inaccordance with the criteria prescribed in the respective information bulletins.

These rules shall be applicable with immediate effect on all ongoing NBEMS trainees as well.

14. Course Fee and Stipend

A. Course Fee:

14.1.The annual course fee for Indian and International students shall be as under:

- 14.2. The fee shall be paid by the student only through Demand Draft/Cheque/electronic transfer and under no circumstances by cash.
- 14.3. The fee has to be paid after the selection of the student but before joining in the allotted training institute.

B. Stipend:

14.4.The following minimum stipend shall be payable to the FNB trainees as per National Board of Examinations in Medical Sciences Stipend Guidelines by the hospital where the trainee is undergoing Fellowship training:

Year	Amount of Stipend (INR)
1st year	Rs. 41,000/-
2 nd year	Rs. 43,000/-

- 14.5.The FNB trainees shall be paid the basic stipend as mentioned above or the basic stipend according to the State Government policy (whichever is higher).
- 14.6.The trainees are required to refer NBEMS web-notice dated 09.09.2024 regarding stipend guidelines and amendments, if any, as may be issued time to time.

15. Exit Examination

15.1. Theory Examination:

- The theory examination comprises of one question paper with maximum marks of 100.
- There are 10 short notes of 10 marks each in the theory paper.
- Maximum time permitted is 3 hours.
- Student must score 50/100 or more to qualify the theory exam.

15.2. Practical Examination:

- Maximum marks: 300
- Comprises of clinical examination and viva
- Centre for practical examination are communicated to all the students separately after the theory examination. The practical of Fellowship Exit Examination shall be conducted at the notified examination centre of the concerned specialty.
- The result of the theory and practical examination will be declared together. The student has to score a minimum of 50% marks in aggregate i.e. 200 out of total 400 marks (Theory & Practical) with at least 50% marks in theory examination to qualify in the Fellowship Exit Exam.
- Each student shall be individually informed by NBEMS regarding his/her examination centre.

15.3. Declaration of Results

• Fellowship Exit Examination is a qualifying examination & Results are declared as PASS/FAIL.

• Successful students in all respects shall be eligible for award of FNB qualification certificate.



Before applying online, a candidate will be required to have a scanned (digital) image of his/her photograph, signature and thumb impression as per the specifications given below. Your online application will not be registered unless you upload your photograph, signature and thumb impression as specified.

A. PHOTOGRAPH

Processes for photo upload:



The candidate shall be required to upload **TWO photographs:**

- 1. A <u>REAL TIME PHOTOGRAPH</u> taken by the webcam/in-built camera of the computer system while filling the online application form:
- a. Confirm that the system used to fill the form has an in-built camera/webcam.
- b. Be properly dressed in a formal attire.
- c. Stand/sit against a **white background** (Avoid distracting backgrounds)


